PRAYER

This writ petition is filed under Article 226 of the Constitution of India, seeking for a Writ of Mandamus, directing the respondents to refund Rs.10,00,000/- payable to the petitioner towards refundable security deposit.

ORDER

This Writ Petition has been filed by the petitioner seeking for a Writ of Mandamus, to direct the respondents to refund Rs.10,00,000/- payable to the petitioner towards refundable security deposit.

2. Mr.D.R.Arun Kumar, learned Standing Counsel, accepts notice on behalf of the respondents. With the consent of the learned counsel appearing for the parties, this Writ Petition is taken up for final disposal at the stage of admission itself.

3. The petitioner made an application to the respondents for establishment of 1 MW Solar Power Plant as per TNERC's Solar Order No.5 of 2018 dated 28.03.2018 and the petitioner has paid a sum of Rs.11,46,809/- on 22.01.2021. Subsequently, the petitioner's proposal was dropped in the stage of making application and load flow study itself. Accordingly, the petitioner has been claiming refund of the refundable security deposit of Rs.10,00,000/- by way of representation dated 01.12.2021. Since the same was not considered, the petitioner has filed this writ petition before this Court for appropriate orders.
