Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the respondents are directed to issue notice to the neighbouring land owners, and also to any other party, if they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the respondents shall conduct survey
