The Criminal Original Petition has been filed to direct the 1st and 2nd respondents not to harass the petitioner.

2. It is the contention of the learned counsel for the petitioner that under the pretext of enquiry, the police is unnecessarily harassing the petitioner.

3.The learned Government Advocate [Crl.Side] on instructions submitted that based on the complaint given by Anbarasan, an enquiry in C.No.298 of 2025 is pending.

4. Such being the position, it is for the investigating agency to issue appropriate notice to the petitioner under Section 35(3) of BNSS for enquiry and on such notice, the petitioner shall appear for enquiry and co-operate in the investigation. It is made clear that the petitioner shall not be harassed during the course of enquiry. If any cognizable offence is made out, the respondent



police shall register a First Information Report and proceed as per law.
