ORDER

This criminal original petition has been filed seeking to direct the respondents not to harass the petitioner under the guise of enquiry in respect of the complaint given by one K.Murugan.

2. When the matter was taken up for hearing, the learned Government Advocate (Criminal Side) appearing for the respondents, on instructions, submitted that as on date, no complaint is pending against the petitioner. However, based on the complaint given by the petitioner, current paper enquiry is pending and that the respondents are not unnecessarily harassing the petitioner and he was called only for enquiry.

3. In such circumstances, it is for the Investigating Agency to issue appropriate notice to the petitioner under Section 35(3) of BNSS for enquiry and on receipt of such notice, the petitioner shall appear for enquiry and co-operate in the investigation. It is made clear that the petitioner shall not be harassed during the course of enquiry. If any cognizable offence is made out, the respondents shall register a First Information Report and proceed in accordance with law.
