PRAYER

Writ Petition is filed under Art. 226 of Constitution of India seeking for issuance of Writ of Mandamus directing the 1st respondent herein to consider the representation of the petitioner dated 25.04.2025 for allotment of tenement in the Pattinapakkam Scheme

Order

This Writ Petition has been filed seeking a direction to the 1st respondent to consider petitioner's representation dated 25.04.2025 for allotment of tenement in the Pattinapakkam Scheme.

2. The contention of the petitioner is that she belongs to fisherman community and living near Marina Beach Area. She has no house in her name. So, she had applied for a tenement in the 2nd respondent Board. Since she was not given any tenement in the Tsunami Scheme, she had sent several representations as well as application under RTI to the 2nd respondent and subsequently, she had sent representation dated 25.04.2025 to the 1st respondent, who is the nodal authority for housing for all scheme. But, so far, there is no action on her representation. Hence, she seeks a direction.

3. Heard Mr.R.Sivakumar, learned counsel appearing for the petitioner, Mr.Yogesh Kannadasan, learned Special Government Pleader appearing for the 1st respondent and Mr.G.Venkatesan, learned counsel for 2nd respondent. Perused the materials available on record.

4. In view of the limited prayer sought in the Writ Petition, this Court directs the 1st respondent to consider the petitioner's representation and pass orders on its own merit within a period of twelve weeks from the date of receipt of a copy of this order.



5. With the above direction, this Writ Petition stands disposed of. There shall be no order as to costs.
