ORDER

This writ petition has been filed seeking for a direction to the respondents 3 and 4 to survey and demarcate the property, which according to the petitioner is owned by him, within a time frame to be fixed by this Court.

2. The petitioner had submitted an online application dated 22.11.2025 seeking for survey and demarcation of the property morefully described in the prayer to this writ petition. Since the said application has not been considered till date, the petitioner has filed this writ petition.

3. Mr.C.Jayaprakash, learned Government Advocate, accepts notice on behalf of the respondents.

4. No prejudice will be caused to the respondents 3 and 4, if the aforesaid application of the petitioner is considered, on merits and in accordance with law, after hearing objections if any from the neighbouring land owners as well as any other party whom they deem fit to enquire. Accordingly, this writ petition is disposed of in the following manner:-

- (a) Before surveying the land in question, the respondents 3 and 4 are directed to issue notice to the neighbouring land owners, and also to any other party, whom they deem fit to



enquire.

(b) After receiving objections if any and after considering the same, the respondents 3 and 4 shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
