4. In view of the above, there will be a direction to the 2nd and 3rd respondents to consider the petitioner's representation dated 30.06.2025 and pass appropriate orders on the same in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

5. This Writ Petition is disposed of with the above terms. No costs. Consequently, connected miscellaneous petition is closed.
