When the matter was taken up for hearing, today, the learned Additional Public Prosecutor, on instructions, submitted that the petitioner had addressed a letter to the respondents-Police on 01.12.2025 stating that her husband S.Selvaraj, S/o.Samidurai, aged 49 years, had returned home voluntarily and therefore, she requested closure of the complaint. The said submission was accepted by the learned counsel for the petitioner.

4. In view of the above, this Habeas Corpus Petition stands dismissed as infructuous.
