(a) Before surveying the lands in question, the respondents are directed to issue notice to the neighbouring land owners and also to any other party, whom they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the respondents 3 and 4 shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
