Prayer : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Mandamus, directing the respondents herein to survey, measure, demarcate and fix the boundaries of the properties belonging to the Vadapura Sengunthar Samudayam, Panapakkam (Association of Persons) contained in Patta No.438 measuring an extent of 16-88.42 hectares/65.67 acres approximately, so as to enable the petitioners to administer the scheme property in terms of

ORDER

2. The petitioners have submitted an application through on-line on 25.11.2025 for the aforesaid purpose. Since the same has not been considered till date, the petitioners have filed this writ petition.

3. Mr.R.P.Murugan Raja, learned Government Advocate, accepts notice on behalf of the respondents.

4. No prejudice would be caused to the respondents if they are directed to survey and demarcate the boundaries of the petitioners'

property morefully described in the prayer to this writ petition, after hearing the objections, if any, from the neighbouring land owners as well as any other party as they deem fit. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the 2nd respondent is directed to issue notice to the neighbouring land owners, and also to any other party, if they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the 2nd respondent shall conduct survey and demarcate the boundaries of the property morefully described in the prayer to this writ petition, on merits and in accordance with law, within a period of twelve (12) weeks from the date of receipt of a copy of this order.

(c) There shall be no order as to costs.
