ORDER

2.Since this Court has expressed the said view to the learned counsel for the petitioner, the learned counsel for the petitioner sought liberty for the petitioner to file a civil suit as against the respondents.

3.No prejudice would be caused to the respondents if such a liberty is granted by this Court.

4.For the foregoing reasons, since this writ petition is not maintainable, in view of the disputed questions of fact involved, this writ petition is disposed of



by granting liberty to the petitioner to file a civil suit against the respondents for the relief as prayed for in this writ petition as well as for any other relief, the petitioner deems fit to seek. No costs.
