Considering the facts and circumstances of the case, the condition imposed by this Court in Crl.O.P.No.30373 of 2025, dated 07.11.2025, is **modified** to the effect that *“the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties each, for a like sum to the satisfaction of the learned Special Court for the Exclusive Trial of EC Act cases and NDPS Act Cases, Salem.”*

4. Accordingly, this Criminal Miscellaneous Petition stands modified.
