ORDER

(The Order of the Court was made by P.Velmurugan, J)

The petitioner is the mother of the detenu S.Kanimozhi. The petitioner stated that her daughter aged about 23 years, has been missing and therefore, she has made a complaint before the Police and a case was registered in Crime No.653 of 2025, dated 29.11.2025. Since the second respondent did not secure her daughter, they have filed the present petition for issuance of a Writ of Habeas Corpus.

2. The learned Additional Public Prosecutor appearing for respondents 1 and 2 submitted that the daughter of the petitioner eloped with the third respondent and they have attained majority and they are aged about 23 years. Even the petitioner herself stated in paragraph 7 of the affidavit filed in support of Habeas Corpus Petition that the detenu and the third respondent married each other and they have surrendered before the Suchindram Police Station in

Kanyakumari District and also produced the marriage photograph. The detenu also gave a letter to the Sub-Inspector of Police, Suchindram that she married the third respondent. Therefore, recording the same, the Habeas Corpus Petition is closed.
