Side), who takes notice on behalf of respondents 1 to 3, submitted that based on the representation dated 25.11.2025 made by the petitioners, an enquiry has been conducted in C.No.H2/SP-GDP/2607/14681/2025 and it has been closed finding that the request of the petitioners was civil in nature with a direction to the petitioners to approach the Civil Court.
