For the foregoing reasons, this Court directs the second respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 15.09.2025, seeking for issuance of computer patta in the name of the petitioner for the property morefully described in the prayer to this writ petition within a period of twelve weeks from the date of receipt of a copy of this order after hearing the objections of the neighbouring land owners if any and any other third party whom the second respondent deems fit to enquire.



6. Accordingly, this writ petition is disposed of. No Costs.
