4. No prejudice will be caused to the respondents, if the aforesaid representation of the petitioner is considered on merits and in accordance with law, after hearing objections, if any, from the neighbouring land owners as well as any other party, whom, the second respondent deems fit to

enquire. Accordingly, this Writ Petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the second respondent is directed to issue notice to the neighbouring land owners and also to any other party, whom, the second respondent deems fit to enquire.

b) After receiving objections, if any, and after considering the same, the second respondent shall conduct survey and demarcate the boundaries of the property morefully descried in the prayer to this writ petition, on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
