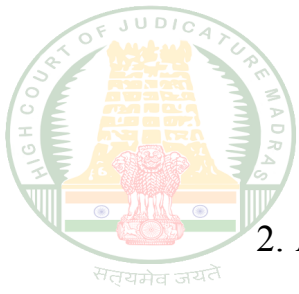
JUDGMENT
