No.B1/3482-16/2025, S.W.D.C. No.B1/3482-17/2025, and S.W.D.C. No.B1/3482-18/2025, dated 27.11.2025 and to direct the 1st respondent to accept the tender documents to be uploaded by the petitioner without insisting for the production of Site Visit Certificate form the respondents for the above said works.
