ORDER
(Order of the Court was made by
the Hon'ble Chief Justice)

Petitioner has filed this petition, aggrieved by inaction on the part of the Corporation in taking any action on his complaint regarding unauthorised dumping of garbage and traffic congestion due to parking of vehicles.

2. Learned counsel for petitioner would submit that representations have been made, but action has not been taken.

3. Roads and pathways have to be kept clear and any unauthorised obstruction is required to be removed. Moreover, garbage dumping is also required to be regulated by the local body. Therefore, the authority concerned in the Corporation shall examine the complaint, conduct spot inspection with regard to alleged garbage dumping and traffic congestion issues and take remedial measures.
