This Second Appeal is filed against the decree and Judgment dated 09.10.2017 passed in A.S.No.21 of 2015 on the file of the Sub Court, Tiruttani, upholding the decree and Judgment dated 18.03.2015 passed in O.S.No.63 of 2012 on the file of the District Munsif Court, Tiruttani.

With the consent of both the parties the matter was referred to the Tamil Nadu Mediation and Conciliation Centre (TNMCC) attached to High Court, Madras, for arriving at an amicable settlement between the parties.
