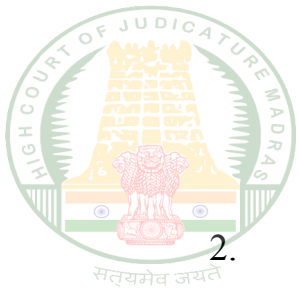

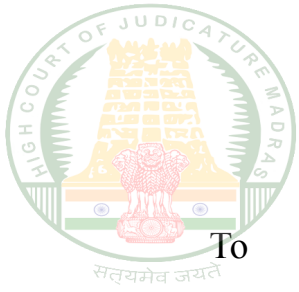
(Order of the Court was made by *S.M.SUBRAMANIAM, J.*)

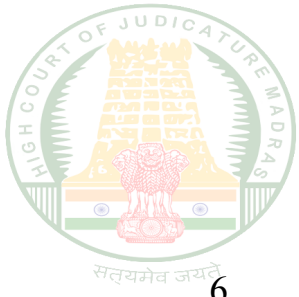
