ORDER

The petitioner, who apprehends arrest in the hands of the respondent police for the offences punishable under Sections 118(1) and 351(2) of BNS (324 and 506 of IPC) in connection with the Cr.No.336 of 2025, seeks anticipatory bail.

2. The case of the of the prosecution is that due to wordy quarrel, the petitioner abused and attacked the defacto complainant with deadly weapon. Due to which, the defacto complainant sustained injuries. Hence, the case has been registered against the petitioner.

3. The learned counsel for the petitioner submits that the petitioner is an innocent person and she has been falsely implicated in this case. He submits that she has not committed any offence as alleged by the prosecution. He also submits that the petitioner is ready to abide by any conditions that may be imposed by this Court and ready to furnish sufficient solvent sureties for her release. He further submitted that injured has been discharged from the hospital. Hence, he prays for grant of anticipatory bail to the petitioner.

4. The learned Government Advocate [Criminal Side] reiterated the prosecution case, and submitted that the injured has been discharged from the hospital. He further submitted that there is no previous case pending against the Petitioner. However, he opposed to grant anticipatory bail to the Petitioner.

5. Heard both sides and perused the materials available on record.



6. Considering the nature of offence and the dispute between the parties and fact that the injured has been discharged from the hospital and also the fact that there is no previous case pending against the petitioner, I am inclined to grant anticipatory bail to the petitioner subject to the following conditions:

7. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy made ready, before the **Judicial Magistrate No.1, Thiruvallur**, on condition that the petitioner shall execute separate bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that:

[a] the petitioner shall report before the respondent police every Saturday at 10.30 a.m. for a period of four weeks.

[b] the petitioner shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade them from disclosing such facts to the Court or to any police officer;

[c] the petitioner shall not leave India without the previous permission of the Court;

[d] the petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter abscond, a fresh FIR can be registered under Section 269 B.N.S.2023.
