PRAYER: Criminal Original Petition filed under 482 of BNSS Act, 2023 to enlarge the petitioner on bail in the event of arrest in Crime No.283 of 2025 on the file of the respondent Police.

ORDER

The petitioner apprehend arrest for the alleged offences under Sections 191(2), 191(3), 296(b), 115(2), 118(1), 351(3) and 109 of BNS, 2023 and Section 3(1) of TN Public Property (Prevention of Damage and Loss) Act, 1992, in Crime No.283 of 2025, on the file of the respondent police, seeks anticipatory bail.

2. The prosecution case is that there was a dispute between the petitioner and the son of the *de facto* complainant. As a sequel, the petitioner along with other persons allegedly went to the house of the *de facto complainant*, abused her using filthy language and attacked her with a knife. Hence, the complaint.

3. The learned counsel appearing for the petitioner would submit that the petitioner is an innocent person and he has not committed any offence as alleged and he had been falsely implicated in this case. The petitioner is ready and willing to furnish substantial sureties for his due release and abide by any condition that may be imposed by this Court and therefore, he prayed to grant anticipatory bail to the petitioner.

4. The learned Government Advocate (Criminal Side) appearing for the respondent police submitted that due to the dispute between the petitioner and the *de facto complainant's* son, the petitioner along with other persons attacked the *de facto* complainant with knife and there is a case and counter case and that the injured was discharged from the hospital and also considering the gravity of offence, he opposed for grant of anticipatory bail to the petitioners.

5. Considering the representations made by both sides and

considering the nature of the offence charged against the petitioner and also there is a case and counter case and that there is no previous case pending as against the petitioner and also taking in consideration of the fact that the injured was discharged from the hospital, this Court is inclined to grant **anticipatory bail** to the petitioners with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen (15) days from the date of receipt of a copy of this order before the **Judicial Magistrate No.V, Vellore** on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only), with two sureties, each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

[a] **the petitioner shall report before the respondent police on everyday at 10.30 a.m. for a period of four weeks;**

[b] the petitioner shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade then from disclosing such facts of the Court or to any police officer.

[c] the petitioner shall not leave India without the previous permission of the Court.

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall make herself available for interrogation by a police officer as and when required.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]*.

[g] If the petitioner thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
