This matter is listed today under the caption 'for withdrawal'.

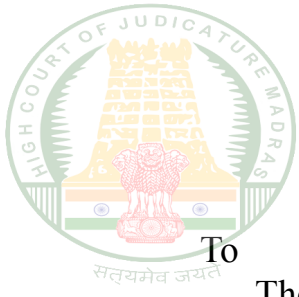
