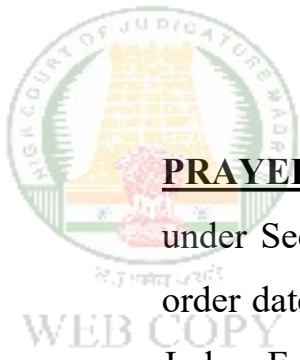

COMMON JUDGMENT

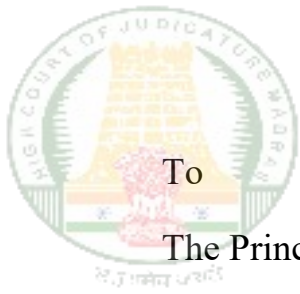
(Judgment of the Court was delivered by C.V.Karthikeyan J.)
