2. In view of the same, the Writ Petition is dismissed for non-prosecution. Consequently, the connected Miscellaneous Petition is closed. No costs.

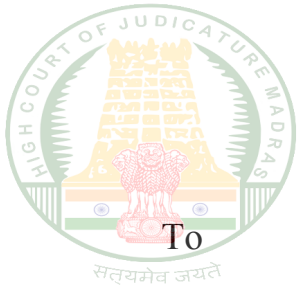
