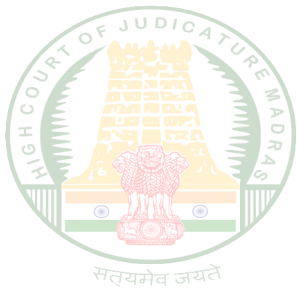

2. The grievance of the petitioner happened in the year 2019. At that point of time, it is claimed that one *Selvaraj* is the President and the petitioner is the General Secretary and the respondent Nos.3 to 5 were not the office bearers and they should not be entertained. The relevant cause of action as well as the period of election of the petitioner Union is now over.

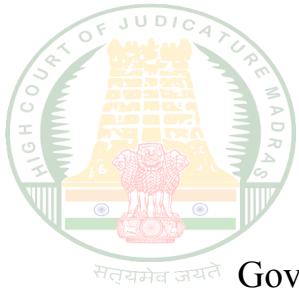
