JUDGMENT

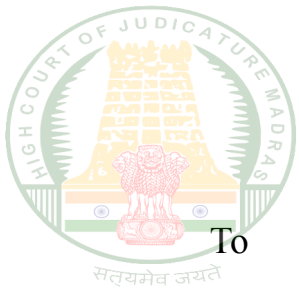
