2.Heard the learned Additional Advocate General for the petitioners and the learned counsel for the respondent.

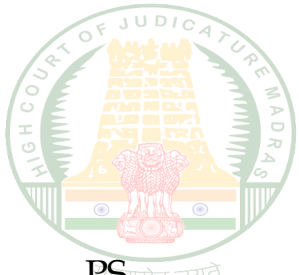
