ORDER

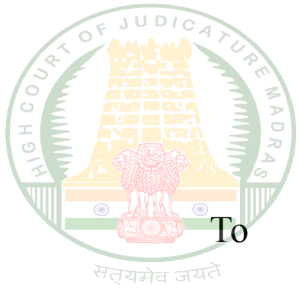
Alleging wilful disobedience of the order dated 12.07.2024, in
