ORDER

The present Writ Petition has been filed by a retired Special Grade Driver Level -5 of the respondent Transport Corporation, who applied for voluntary retirement on 31.03.2023, seeking a Mandamus for payment of interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, though the petitioner had voluntarily retired from service on 31.03.2023, the terminal benefits were released only on 30.10.2024. Hence, the petitioner has addressed a communication to the respondents on 04.11.2024, seeking payment of interest for the belated disbursement of terminal benefits. Since there is no response, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.
