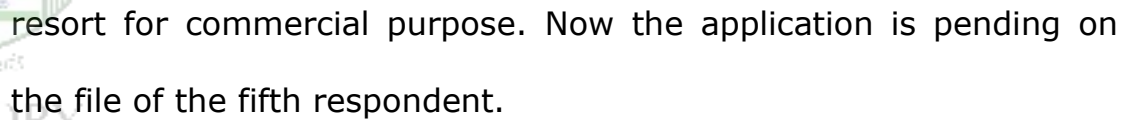

This Writ Petition has been filed challenging the impugned order passed by the first respondent District Collector(in charge) and District Revenue Officer vide proceedings in Mu.Mu. (C2)/50732/20210, dated 8.10.2021(received on 21.10.2021) and to quash the same and further to direct the respondents to grant permission to run the Petitioner's resort namely "Cabana Coral Reef".
