This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.D.Sivaraman and the counsel for the first respondent Mr.A.Sivasubramanian are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both the parties and their respective counsels are present and they arrived at an amicable settlement for a sum of Rs.4,50,000/- [Rupees Four Lakhs Fifty Thousand] along with interest at the rate of 7.5% from the date of filing of the petition with costs.



2.It is submitted that amount of Rs.3,82,013/- (Rupees Three Lakhs and Eighty Two Thousand and Thirteen only) along with interest at the rate of 7.5% has already been deposited before the Tribunal. The appellant is directed to deposit the remaining amount of Rs.1,20,000/-, (Rupees One Lakh and Twenty Thousand), which includes interest, within a period of three weeks from today. The claimant/ first respondent is permitted to withdraw the entire agreed amount along with interest and costs, on filing proper petition before the Tribunal.
