2. Heard the learned counsel appearing for the petitioners. Since the revision is filed for seeking early disposal, no notice is necessary to the respondents.

3. The learned Counsel appearing for the revision petitioners would submit that the respondents herein / plaintiffs have filed the above suit in O.S.No.315 of 2016 on the file of the Sub Court, Madurai for partition and the same is pending for the past 8 years without any progress. He would further submit that most of the parties in this case are senior citizens and hence, the said case may be disposed of within the time stipulated by this Court.
