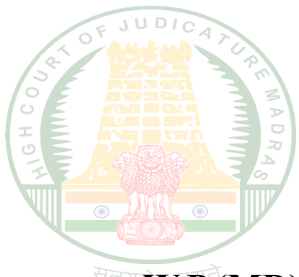

2.However, it is brought to the knowledge of this Court that for the same relief, already a writ petition in W.P.(MD)No.17473 of 2020 was filed and the same was dismissed, vide order, dated 22.02.2024. Aggrieved over the same, the writ petitioner had preferred a writ appeal in W.A.(MD)No.1546 of 2024 and interim stay was not granted in the said writ appeal. The writ petitioner is at liberty to raise all the grounds in that writ appeal.

3.Hence, the writ petitions are dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
