While being so, the respondents are attempting to lay a road in the petitioner's patta land. Therefore, the petitioner submitted a representation to the respondents not to lay any road in his patta land without due process of law.

5. The learned Government Advocate appearing for the respondents on instructions would submit that there is no proposal to lay any road in the property comprised in Survey No.212/1A and 212/2A in Papakudi Village Bit-1, Cheranmahadevi Taluk, Tirunelveli District.
