## **ORDER**

The present Writ Petition has been filed by a retired Non-IT-Helper of the respondent Transport Corporation, who had attained superannuation on 31.01.2023, seeking a Mandamus for payment of interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, though the petitioner had retired from service on 31.01.2023, the terminal benefits were released only on 30.10.2024.
