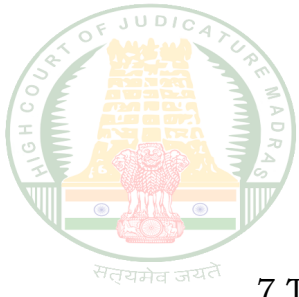

4.Heard the learned counsels on either sides and carefully perused the materials available on record.

5.The learned Government Advocate Mr.S.Kameswaran on written instructions submitted that, the 5<sup>th</sup> respondent has commenced the installation of the wind-mill and the said property is his patta land. However, he fairly conceded that he is unaware as to whether the 5<sup>th</sup> respondent has obtained proper permission from the competent authorities.

6.In view of the said submission, this Court hereby direct the respondents 1 to 4 to consider the petitioner's representation dated 18.11.2024 and pass appropriate orders in accordance with law within a period of six (6) weeks from the date of receipt of a copy of this order and in case it is identified that the 5<sup>th</sup> respondent has commenced the installation of the windmill without proper permission, the same shall be stalled.
