This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellants Mr.S.Micheal Heldon Kumar and the counsel for the respondents 1 to 5 Mr.J.Arul Prakash are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.



## AWARD



Both the parties and their respective counsels are present and they arrived at an amicable settlement for a sum of Rs.8,40,000/- [Rupees Eight Lakhs and Forty Thousand only] as full quit.

2.It is submitted that Rs.25,000/- [Rupees Twenty Five Thousand] of the award amount has already been deposited before the Tribunal. The appellant is directed to deposit the remaining amount, within a period of four [4] weeks from today. The claimant/ first respondent is entitled to Rs.3,32,000/- [Rupees Three Lakhs Thirty Two Thousand only] and the respondents 2 to 5 are entitled to Rs.1,27,000/- [ Rs.One Lakh and Twenty Seven Thousand only] each. The claimants are permitted to withdraw the settled amount as agreed to above, on filing proper petition before the Tribunal.

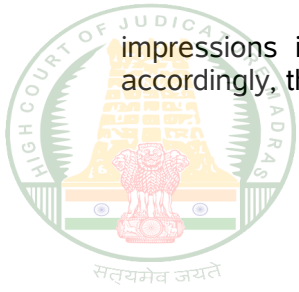
### **Counsel for the Respondent/s**
