ORDER

The present Writ Petition has been filed for the issuance of a Writ of Mandamus, to direct the respondents 1 and 2 from in any manner selling the TELC properties comprised in S. No.43/1 of an extent of 2 Acres 51 cents situated at Hospital Road, Pattukottai, Thanjavur District by considering the petitioner's representation dated 19.12.2023.

2. It is seen from the records that the official respondent have rejected to register the sale deed since the land belongs to the temple. This issue was already considered by this Court in the case of ***Sudha Ravi Kumar and Another Vs. The Special Commissioner and Others*** in W.P.Nos.30589 of 2013 and batch, dated 05.04.2017, wherein it is directed to issue notice to the petitioner and the temple and conduct enquiry and pass orders.

3. Accordingly, this writ petition is allowed. The official respondents are directed to conduct an enquiry and pass orders in accordance to law, after issuing notice to both the parties, within a period of four weeks from the date of receipt of a copy of the order. No Costs.
