Since a peace committee meeting has been conducted between the petitioner and the respondents 6 to 9 and a resolution has also been passed, the petitioner and the respondents 6 to 9 are permitted to conduct the Kumbabisheegam in KIDAPOORI AYYANAR TEMPLE at Kidapoori village, Mutharan Post, Sivagangai District as per the terms and conditions of the resolution.
