In pursuant to the request made by the petitioner, the second respondent conducted a peace committee meeting and resolved that nobody is permitted to encroach the property comprised in Survey No. 182/56 and 182/46, situated at Adidraavidhar natham, Pallapatti village, Kottampatti, Melur Taluk, Madurai District, since there is a dispute between two groups. The said land is a common place and used to as playground and community hall. Therefore, other than the purpose for subject land is ear-marked, it cannot be used for any other purpose. If there is any law and order issue, the concerned Revenue officials as well as the Police officials are directed to take appropriate action as against them.

4. With the above observation, this Writ Petition stand disposed of . No costs.
