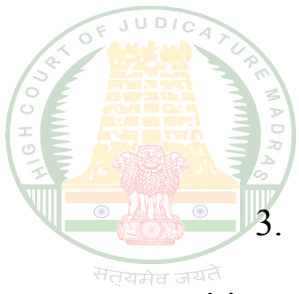

ORDER
