3. Today the learned Government Advocate appearing for the respondents 1 to 4 would bring to my notice the proceedings of the Pudukkottai District Revenue Officer in Moo.Moo.930249/2023/E2, dated 05.12.2023, whereby, the request of the petitioner for patta has already been rejected.

4. The learned counsel for the petitioner however submitted that the said rejection order has not been communicated to the petitioner
