ORDER

This petition has been filed by the petitioners to call for the records pertaining to C.C.No.202 of 2023 on the file of the Judicial Magistrate, Devakottai, Sivagangai District for the offences under Sections 341, 387 and 506(2) of IPC in Crime No.48 of 2023 and quash the same.

2. Based on the complaint given by the defacto complainant, the police has registered FIR in Cr.No.48 of 2023 for the offences under Sections 341, 387 and 506(2) of IPC.

3. When the matter was taken up for hearing, the learned counsel on both sides represented that during pendency of the case in C.C.No.202 of 2023, the matter has also been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

4. Today, the defacto-complainant and all the accused are present and the Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise. A compromise memo, dated 06.01.2025 signed by the parties and their respective counsels, is also filed before this Court.

5. This Court has perused the terms of the compromise memo.

6. Considering the nature of the offences, and the fact that the parties have also entered into a compromise, it is appropriate to allow this petition.

7. Recording the said compromise memo, this petition is allowed and C.C.No.202 of 2023 on the file of the Judicial Magistrate, Devakottai, Sivagangai District is quashed. The compromise memo dated 06.01.2025 filed by the parties shall form part of this order. Consequently, connected miscellaneous petition is closed.
