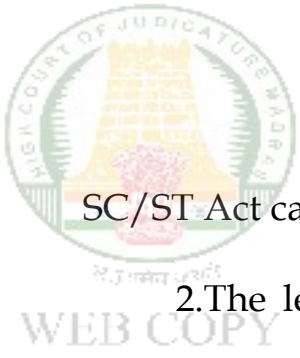
Prayer in CRL OP(MD).No.16803 of 2024:-
