ORDER

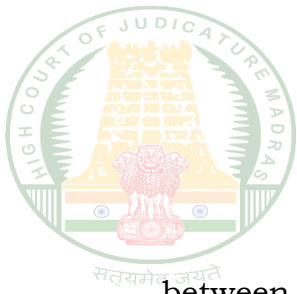
By consent of both the parties, this writ petition is taken up for final hearing at the admission stage itself.
