The petitioner has filed the present Writ Petition for a direction directing the respondents Nos.1 to 6 to remove the encroachment made by the respondents Nos.8 to 14 in the seventh respondent school playground in Survey No.290/1B to an extent of 9540 Sq.Mtr in Thiruvadanai Village, Thiruvadanai Taluk, Ramanathapuram District and to take effective steps to mutate the revenue records of the said playground in favour of the seventh respondent school by considering his representation dated 29.12.2022.

2.Today, when the matter is taken up for hearing, the learned Additional Government Pleader appearing for the respondents 1 to 6 would
