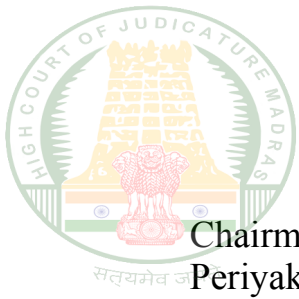

The learned counsel appearing for the petitioner would submit that the relief sought for in the present Writ Petition has become infructuous. Therefore, this Writ Petition may be closed.

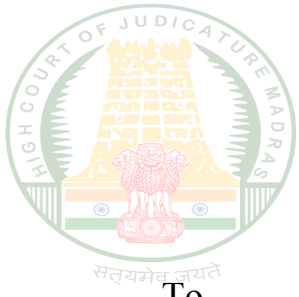
2.In view of the said submission, this Writ Petition is closed. No costs.
