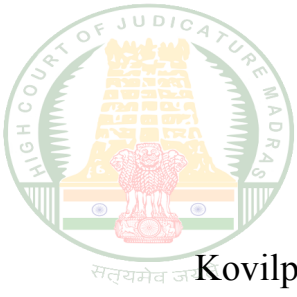
dispose the DVC.No.29 of 2023 pending on his file within a time frame fixed by this Court.

2. Heard the learned counsel appearing for the petitioner. Since the revision is filed for seeking early disposal, no notice is necessary to the respondents.

3. The learned Counsel appearing for the revision petitioner would submit that the marriage between the petitioner and the 1st respondent was solemnized on 04.09.2019 as per Hindu Rites and Customs. Due to matrimonial discord, the petitioner herein was sent out from the matrimonial home and thereafter, she filed a petition for seeking divorce and also maintenance case.
